# Victim Information & Notification Everyday (VINE)

Victim Information & Notification Everyday (VINE) is a victim notification network that can be accessed 24 hours a day, seven days a week. The purpose of VINE is to provide victims with a sense of security, as well as reliable custody status changes and criminal case information. VINE is able to provide service information by phone, email, TTY, and text message.

In order to register for status changes, a 4-digit pin will be required.
